



PRIVACY POLICY

Screen Tek Printing Co., Inc. (Screen Tek) is committed to protecting your privacy. This Statement of Privacy applies to Screen Tek's web site and governs data collection and usage at all Screen Tek sites and services; it does not apply to other online or offline sites, products or services. COLLECTION OF YOUR PERSONAL INFORMATION

Screen Tek does not collect any information about your computer hardware and software.

USE OF YOUR PERSONAL INFORMATION

Screen Tek and its operational service partners collect and use your personal information to process product orders and deliver the products requested. It is possible that Screen Tek may also use personal information to inform you of other products or services available from Screen Tek and its affiliates. Screen Tek may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered. Screen Tek does not sell, rent or lease its customer lists to third parties. Screen Tek may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your personal information (e-mail, name, address, telephone number) is not transferred to the third party.

We occasionally hire other companies to provide limited services on our behalf, such as handling the processing and delivery of mailings, providing customer support, processing transactions, or performing statistical analysis of our services. We will only provide those companies the personal information they need to deliver the service. They are required to maintain the confidentiality of your information and are prohibited from using that information for any other purpose.

Screen Tek does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Screen Tek may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Screen Tek or the site; (b) protect and defend the rights or property of Screen Tek, including its web site; or (c) act under exigent circumstances to protect the personal safety of users of Screen Tek or the public.
